



# **RXP AND ROCKBOTTOM RESTAURANT AND BREWERY “FREE BREW FRIDAY” OFFICIAL RULES**

## Description of Promotion/Participation

1. **The Alternative RXP at 1039 and Rockbottom Restaurant and Brewery may be referred to “The Sponsors” from this point forward.**
2. **Dates of Promotion:** Every Friday since 6/1/17.
3. **How to Enter: No Purchase Necessary**
